RE: New World Screwworm Threat

Dear Secretary Rollins,

On behalf of livestock and dairy producers, markets, wildlife managers, equine owners, agribusiness, animal health companies, and landowners across the nation, the undersigned organizations write to express our ongoing concern regarding the threat of New World screwworm (NWS) and to call for continued and focused federal leadership to prevent a catastrophic outbreak in the United States.

We are grateful for the U.S. Department of Agriculture's (USDA) recent announcement at Moore Air Base regarding USDA's five-pronged plan for NWS Domestic Readiness and Response Initiative. The establishment of a sterile fly dispersal facility in partnership with the Panama-United States Commission for the Eradication and Prevention of Screwworm (COPEG) is a critical step forward in rebuilding our domestic defense against this devastating pest. However, much work remains. The U.S. still lacks a domestic sterile fly production facility, the foundation of any long-term eradication and response strategy.

Therefore, the undersigned organizations urge the Administration to immediately secure full federal funding and begin construction of a domestic sterile fly production facility. The Animal Health Protection Act was enacted to provide the Secretary with the necessary resources to protect our country and swiftly respond to animal disease and pest threats like NWS. We urge the USDA to use the powers granted under this act or any other avenue to fully fund this facility.

We recognize that other ideas have been proposed for combating NWS, but the sterile insect technique (SIT) remains the most proven, effective, and science-based solution available for eradication. Livestock and dairy producers, wildlife managers and producers across the nation are growing more concerned as the NWS moves northward to the U.S. border and know we must be armed with a domestic production facility. We respectfully ask that the USDA and leaders in Washington continue prioritizing and pursuing funding and regulatory coordination to begin immediate construction.

The stakes are simply too high to delay. USDA estimates that a NWS outbreak in Texas cattle alone could result in \$1.8 billion in annual losses, including \$732 million in direct impacts to producers. But the damage wouldn't stop there.

Nationally, the U.S. is home to over 71 million pigs, 5 million sheep, 2.5 million goats, more than 9 billion chickens, and 6.65 million horses, all of which are vulnerable to NWS infestation. If an outbreak were to spread across states within the historic NWS range, national livestock losses could exceed \$4.3 billion annually, with total economic damages surpassing \$10.6 billion. The U.S. horse industry alone contributes \$177 billion to the national economy and stands to suffer significant losses should NWS spread.

Wildlife would also be severely impacted. Losses to game and nongame animals alike threaten our \$400 billion wildlife-recreation economy and North American Model of Conservation Funding that it supports. Rural economies and viability of working lands are closely tied to the health and sustainability of our native wildlife populations. Also of great concern are potential threats to the costly ongoing recovery of threatened and endangered species nationwide. Losses to the nation's wildlife and livestock are not hypothetical. They are real, and they are preventable.

We sincerely appreciate the steps you and your team have already taken, and we thank you for your attention to this threat. We understand you and your team at USDA are working diligently on all viable solutions, and we consider you a partner in these efforts. However, the danger of NWS is far from over, and our members are growing more concerned as it approaches our country.

A domestic sterile fly production facility is the cornerstone of this effort. It is what our producers and partners are asking for and desperately need. Therefore, it remains our top priority. Thank you again for your steadfast efforts.
